

The aim of this qualification is to prepare students to work with children between birth and five years with knowledge of children up to seven years or to progress onto the T Level in Education and Childcare or the CACHE Level 3 Diploma for the Early Years Workforce.

### **COURSE DETAILS**

The course is rewarding, challenging and requires a great deal of commitment and motivation. Placement experience is an integral part of the course In order to aid holistic delivery and assessment the units are structured around the following four themes:

- Theme 1: Introducing the role of the Early Years Practitioner
- Theme 2: Legislation, frameworks and professional practice
- Theme 3: Play, development and learning for school
- Theme 4: Professional development

Placements are required for achievement of this qualification. A minimum of 250 placement hours is required. Placements will be undertaken in at least 2 different settings to cover the age ranges.

## **ENTRY GUIDELINES**

This is a Study Programme and applicants must be 16 or 17 years of age when applying (on or before 31st August)\*. This is Government Guidelines.

Relevant Level 1 qualification or a minimum of 4 GCSEs including English Language Grade 4/C and 3 GCSEs at Grade 3/D or above (including maths).

Applicants should be ready to complete a substantial Early Years (0-5yrs) work placement

Satisfactory interview, assessment, school report and a positive references from your last place of education or training.

Satisfactory DBS

All units will be internally assessed using a range of methods.

This could include direct observation within the workplace, a portfolio of evidence, written assignments or a task set by CACHE\*.

# **ADDITIONAL INFORMATION**

At interview you will need to:

- Show evidence of current or projected GCSE results.
- Demonstrate level 1 English in the assessment and interview which includes speaking, listening, reading and writing.

- Complete a DBS (Disclosure and Barring Service).
- Show that you are motivated, committed and have excellent punctuality and attendance.
- Provide your school report and reference.
- Present a Record of Achievement from your last school.

#### Are you aged 16-18?

**Study programmes** are full-time courses for 16-18 year olds which include:

- A qualification such as BTEC Extended Diploma
- Meaningful work experience or preparation for work
- English and maths, if you don't already have GCSE grade A\* C or Grade 4 or above in English and maths
- Non-study activities such as tutorials, voluntary work, fund-raising/charity work, sport or trips

### WHERE CAN I PROGRESS TO?

When you have successfully completed your course you may be able to progress (although not automatic and ensuring Level 3 entry requirements are met) to the T Level in Education & Early Years qualification or other Level 3 qualifications, including apprenticeships relating to childcare. There are also many employment opportunities in the Childcare and Education sector, such as Nursery assistant, Classroom assistant, Pre-school assistant and Nanny.
